



Terms & Conditions

1. Tag-Along Tours of Australia ("Tagalong Tours") makes every effort to operate all tours as advertised.
2. I/We understand that Tagalong Tours operates tours in remote areas and reserves the right to amend, vary, re-route, or cancel when in its best judgement, road conditions, climate, or other circumstances deem it to be necessary.
3. I/We agree that participation in any tour organised by Tagalong Tours is voluntary.
4. Tagalong Tours does not guarantee exact arrival and departure times.
5. At the discretion of Tagalong Tours, a tour may not proceed if minimum numbers are not achieved. Tagalong Tours shall advise participants as soon as possible should the tour not proceed under this clause.
6. No pets are permitted on any Tagalong Tours.
7. I/We understand and accept that tours offered by Tagalong Tours are challenging, self sufficient 4WD experiences and at times traverse remote areas.
8. I/We agree to observe the safety instructions of the authorised Tagalong Tours tour leader/s for the duration of the tour and any other instructions as given from time to time.
9. I/We understand and accept that all bookings made with Tagalong Tours are subject to the terms and conditions and limitations and liability imposed by the other suppliers, some of whom limit or exclude liability in respect to death, personal injury or delay.
10. I/We understand and accept that Tagalong Tours is not in any way liable for the acts, omissions or default whether negligent or otherwise, of the other suppliers.
11. Whilst every care and precaution is taken, I/We understand that Tagalong Tours of Australia is not liable for the sickness or injury of any participant.
12. I/We confirm that we do not have any pre-existing medical condition or disability which will impact on or prevent me/us from participating in or completing this tour.
13. I/We accept that where a tour is carried out in an area with limited medical services, Tagalong Tours and its employees and agents are expressly authorised by me/us and each participant for whom we are responsible to take such action as is necessary for the provision of medical services. This shall include, but not be limited to, the arrangement of any medical evacuation service by air/road, the attendance of any doctor, nurse, paramedic or ambulance officer and any necessary hospital service.
14. I/We understand that all the associated costs of the provision of medical services as specified in Clause 13 are to be borne by me/us.
15. I/We accept that should our vehicle break down, Tagalong Tours will do all that it can without jeopardizing the other participants to ensure the recovery of the vehicle. I/We understand that the tour

price does not include the cost of any vehicle repairs, towing expenses or any other third party costs that may be incurred by the participant in order to continue the tour.

16. I confirm that I and any of my co-drivers am/are in possession of a valid Australian driver's licence.

17. I/We accept responsibility for my/our vehicle and the persons in that vehicle and acknowledge that I/we are expected to demonstrate a duty of care to all other road users, members of the public and other tour participants.

18. I/We accept full responsibility for the maintenance of my/our vehicle during the tour. This includes regularly checking batteries, water and oil levels and tyre pressures.

19. I/We understand that I/we will be liable for any traffic offences incurred by me/us during the tour.

20. I/We acknowledge that in the event that Tagalong Tours arranges/facilitates the hire of vehicles or other equipment for a participant, the contract and terms & conditions for use of that equipment is between the participant and the supplier of the goods.

21. Tagalong Tours strongly recommends that all participants have some form of vehicle insurance in addition to third party insurance as well as a premium roadside service cover with the relevant motoring body from their State eg RACV, NRMA or RACQ.

Bookings & Cancellation Policy

22. I/We accept that to make a booking, I/we must provide Tagalong Tours with written, faxed or emailed Booking Form along with a deposit of \$500 payable to Tagalong Tours of Australia by bank deposit, cheque, money order and posted to:

Confirmation of the booking will be issued once the Booking Form and payment has been received.

23. I/We accept that the final balance of the amount payable is due no less than 30 days prior to departure. If a booking is made within 30 days prior to departure, full payment is required with the Booking Form in order to secure the booking.

24. I/We accept that should it be necessary to cancel my/our booking, I/we must notify Tagalong Tours immediately in writing, and the notification will take effect once it is received by Tagalong Tours. Any cancellation may be subject to penalties as set out in the schedule below:-

Cancellation Date	Penalty
More than 30 days prior to departure date	No penalty
15 - 30 days prior to departure date	Loss of deposit
8 - 14 days prior to departure date	50% of full payment
7 days or less prior to departure date	75% of full payment
Failure to depart on tour	No refund
Leaving during tour	No refund

25. I/We accept that should Tagalong Tours fill a vacancy, as considered in Clause 25, by another full paying client prior to the tour departure date. Tagalong Tours will refund money in full less the deposit.

26. Tagalong Tours strongly recommends that all participants take out travel insurance cover.

27. Tagalong Tours, its employees or agents, do not accept any liability for any damage to any persons or property resulting from the actions of participants.

28. These Terms and Conditions are incapable of alteration or waiver by an employee, agent or representative of Tagalong Tours or by any other supplier.

29. I/We agree that it is my/our responsibility to obey all state and local laws especially in relation to the limited transportation and use of alcohol. Tagalong Tours will do all that it can to offer advice in these areas, however Tagalong Tours does not take any responsibility for the possession of any alcohol whilst in these restricted areas.

30. I/We give my/our permission for Tagalong Tours to use any digital film or video/still photographs that may be taken of participants, in its advertising or on its web site.

31. Notwithstanding anything contained in this Agreement to the contrary, Tagalong Tours shall not be liable for any loss, injury, delay, damage or other casualty suffered or incurred by participants due to storms, fires, earthquakes, explosions, embargoes, government directives, or any other law or regulation, litigation or labour dispute, act of God (such as flood), war, terrorism, or any other cause which is beyond its reasonable control.

32. This Agreement is, and shall be governed by, and construed in, accordance with the law of the State of Queensland.

33. Any legal conflict which may arise under this Agreement shall be resolved in the legal jurisdiction of Queensland.
